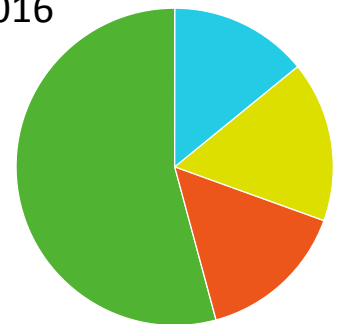
Percentage Of U.S. M&A Transactions By Company Value in 2016
